**Quorum Confirmation** - 93 members in attendance. Quorum confirmed.

3. Review and Accomplishments

Presentation by CEO Fouzan Khan and land acknowledgement of the traditional land of the Anishinaabe First Nations of Mississauga.

The ongoing pandemic has posed a challenge for in person programming. Programs have been adapted to continue serving the community. Virtual programming and events were offered throughout lockdown periods. An Act of Kindness campaign was launched and driven by the community to make a difference in the lives of others.

ISNA Canada partnered with Paramount to provide free meals for long term care staff during a touch outbreak period in these spaces. COVID relief boxes continued and 1993 boxes were distributed to the community.

The volunteer engine was launched to allow volunteers to log hours and create profiles. Volunteer opportunities are posted and allows for better organization and engagement. Currently there are 580 active volunteers and 8583 volunteer hours have been completed.

The new website was launched and provides a youthful and dynamic website. There is still much need for improvement that ISNA Canada is currently working on. ISNA Canada's current reach is 17,782 for the email list and 27,558 for facebook. ISNA Canada is continually working to improve reach on various platforms such as Whatsapp, Instagram, Twitter and YouTube.

Over 20 unique programs were offered during Ramadan 2021. Virtual programming was done using a professional studio to produce high quality programs such as To my Daughter and Our Story. Another highlight program was 30 for 30 that brought in leading scholars of our time to this platform. Drive-thru and Drive-in iftars continued this year and the experience grew with additional days added to the service. Over 24,888 meals were served with the support of over 18 restaurants. Iftar programs were offered at Jami Mosque and Yellowknife. Many of our political leaders including Jagmeet Singh joined our community during Ramadan, This brought a lot of positive News Coverage Global News, CTV and CBC.

ISNA Canada has gone through a reorganization structure to help us become the leading national muslim organization. Canada Summer Job was a major support with 32 approvals.

New projects completed at the center include the pavement project and the Youth Hub. Looking ahead, the hope is to move ISNA Canada to be the leading national muslim organization while focusing on the needs of our local community. ISNA Canada is committed to building the Yellowknife Centre and offering the support needed.

### 4. Approval of Agenda

#### 5. Approval of Financials

Mostafa Soliman presented the Summary of 2020 financials. Due to the pandemic, revenue has decreased 11% from previous years. The organization's expenses have remained relatively the same due to the increase in services to the community. Revenue from services decreased due to the increase of free services and activities. Grant revenue has increased while cash flow has decreased slightly due to some major capital expenditures such as the pavement project.
